# TOWN OF CANAJOHARIE MONTGOMERY COUNTY

# **January 3, 2013**

The Town Council met for a regular monthly meeting, and for the reorganization meeting for 2013.

**Present:** Supervisor Herbert Allen, Councilpersons William Armitstead, Judith Burgess, John Toomey, Jr., and Rodney Young; Bookkeeper Amy Kretser, Highway Superintendent Eric Bowerman, and Joshua Thomas of the Courier-Standard-Enterprise.

The meeting was opened by the Supervisor at 7:30, and the evening's agenda was presented.

On a motion by Councilman Toomey, seconded by Councilwoman Burgess, the agenda was approved.

On a motion by Councilwoman Burgess, seconded by Councilman Young, the **minutes** of the December meeting were unanimously approved.

Highway Superintendent may purchase snowplow blades, not to exceed \$6,000, without prior board approval.

Highway Superintendent, per CSEA contract and council approval, may offer additional time off in recognition of the extra duties of his deputy.

Utility bills may be paid ahead of monthly council meeting.

Postage for the postage meter may be paid for ahead of the monthly council meeting.

Resolution #1 was unanimously approved.

#### **LEGISLATURE**

#### **Animal Shelter Contract**

The annual contract with the Ayres Animal Shelter, for housing of stray dogs, needs to be renewed and paid. The amount is the same as prior years, \$4,500.

Supervisor Allen made a motion to renew and sign the contract with the Ayres Shelter for 2013. The motion was seconded by Councilwoman Burgess. All were in favor; motion passed.

# **Buildings** – heating

The upgrade to the heating system at the Town office building has been completed by Don's Electric. There are new thermostats, set on timers, and new duct work. With thermostats in the clerk's office and court office, as well as the courtroom, the heat should be better distributed.

# **Buildings** – porch work

The work to cover the back doorway should be started next week, as all information and a contract have been received from Double O Builders.

# Agreement for expenditure of highway moneys

The Highway Superintendent brought the annual agreement for expenditure of highway moneys to the Council for signature approval. This agreement between Montgomery County and the Town allows for the sum of \$258,060 to be set aside for general repairs on 35.44 miles of Town roads, and for \$61,200 in CHIPS money for permanent improvements. The roads to be worked on with CHIPS money are yet to be determined, but Mr. Bowerman said they would probably include Old Fort Plain and Sprakers Roads.

#### **NEW BUSINESS**

Mr. Allen presented a list of items that should be addressed in the coming year, including:

- Look at the recycling contract
- Complete the project, previously discussed, of taking out the closet on the first floor and making a hallway to the boiler room
- The enactment of a local law to allow for contracts to be awarded on the basis of "best value" and not only on lowest bid

- The enactement of a local law, once again, to allow for override of the State tax cap
- An earlier discussion of fire contracts (August)
- Reappointment of the assessor, whose term expires in September
- Finding land for the site of a new town garage

#### HIGHWAY

Superintendent Bowerman reported on activity for the past month. The propane supplied by Suburban Propane is being used up, and once the second tank is empty, Suburban will be called to come remove the tanks. A first delivery at the rate of \$1.56 per gallon was received from Parsons. Next month, the Town will be billed to buy the tank from Parsons, and then will go to the lower per gallon price, as formerly agreed.

The bond for the new truck will need to be taken care of by the attorney, though this can't be done too far ahead of receipt of the truck. Mr. Bowerman suggested the possibility of paying ahead for the nose plow, and not including it in the bond, to save interest on the loan.

#### TOWN CLERK

Clerk/Collector Susan Smith reported that the 2013 County/Town property taxes are coming out late this year, and should be received by January 11<sup>th</sup>. The first deadline for payment will be extended to February 10<sup>th</sup>.

Ms. Smith also let the council know that the Town website, an offshoot of the Montgomery County website, is now up and running. She will email a link to the councilmembers.

The annual Clerk's report is included in the informational packet.

#### **BOOKKEEPER**

Bookkeeper Amy Kretser reported briefly on her cash report, which includes a lot of fund transfers to be approved. She said she still has some budget gaps to catch up with, and will be bringing everything into balance. (Report is copied on next page.)

# **BILLS**

The clerk presented the following bill vouchers for approval:

General fund vouchers #1 through #22, totaling \$50,869.72; and

Highway fund vouchers #1 through #16, totaling \$34,504.61

On a motion by Councilman Armitstead, seconded by Councilman Toomey, the bills were unanimously approved for payment, and all fund transfers outlined in the cash report were also approved.
