The Town Council met for a regular monthly meeting at the Town Hall building, 12 Mitchell Street, Canajoharie, New York.

The meeting was opened by the Supervisor at 7:30, and the evening's agenda was presented

On a motion by Councilman Toomey, seconded by Councilwoman Burgess, the **agenda** was unanimously approved.

Motion to reappoint Michael Cole to the Board of Assessment Review until 9/30/2018 made by Supervisor Allen, seconded by Councilman Toomey, all in favor and unanimously approved.

Resolution #*3of 2014 to Renew Bond taken out for 2013 Freightliner in the amount of \$152, 231.24 at 2% interest, sponsored by Councilman William Armitstead and Seconded by Councilman John Toomey

*Resolution #3 of 2014: 2013 Truck Bonding Renewal

Whereas, the Town of Canajoharie is renewing of bond for 2013 truck Whereas, the principal amount of the Bond is \$188,462.00 with accrued interest of \$3,769.24, for a total indebtedness of \$192,231.24;

Resolved: The Town Council authorizes the Town Supervisor, Herbert T. Allen, to pay \$40,000.00 plus accrued interest of \$3,769.24, for a total of \$43,769.24, to reduce the principal amount of the Bond and renew the remaining principal balance of \$148,462.00 on said Bond, for a new one (1) year term.

The Town Board unanimously approved Resolution #3of 2014 by voice vote.

Motion for Supervisor Allen to find attorney to draw up bond made by Councilperson Judy Burgess, seconded by Councilman Rodney Young.Discussion as to any attorney preferences from the Board. Attorneys Kirkpatrick and Kruger were mentioned. Supervisor Allen will check with both and with Attorney Dunn to find out prices and length of time to complete bond paperwork. All in favor and motion unanimously passed.

Councilmen inspected and signed the Court report.

Supervisor Allen would like to arrange a meeting with the Board, assessor, Mayor, and Montgomery County Real Property and Bob Jacobs of the New York State Department of Taxation regarding a town-wide reassessment. It would be an informational meeting only.

The Town Court has received notice that the Grant applied for to fix the entranceway and doors to the Justice and Court Clerk's office has been approved in the amount of \$20,000.00.

Court Fund 2013 was presented to the Board; Total money received from the Court \$70,099.00.

Supervisor Allen and Highway Superintendent Hodge are working on a workplace violence policy with Dominick Timpano of the New York State Department of Labor.

Supervisor Allen needs two volunteers to look over old procurement policy and update the information—Councilmen Armitstead and Toomey volunteer.

Supervisor Allen indicates that Michael Ehrenreich would like to be on Zoning Board of Appeals. He will also contact David Schultz.

Supervisor Allen presents the Ames Fire District call report for 2013; 37 emergency calls responded to.

HIGHWAY

Superintendent Hodge would like permission to look for bids for a new generator to run a steamer. The current generator does not work. Would also like permission to look for bids on a 1988 tractor that caught on fire last year.

His men have been doing a great job keeping up with the storms.

Discussed John Klock's retirement which will now be in June, need to search for new deputy highway supervisor
