Resolution by Canajoharie Town Board Accepting Contract for Snow Removal and Ice Control and Grass and Brush Mowing on County Roads Beginning January 1, 2015 and Ending December 31, 2016

Sponsor: Councilman Young Seconded: Supervisor Allen

Whereas, the Commissioner of Public Works of this County has submitted a contract for the removal of snow and ice control and mowing of grass and brush from county roads within the Town of Canajoharie under Section 135A of the Highway Law, now therefore be it and it

Resolved, that pursuant to Section 135 A of the Highway Law, this Board accept the contract for snow removal and ice control and grass and brush mowing, and authorizes the Town Supervisor to execute the aforesaid contract

All in favor, unanimous Ayes, carried

Supervisor Allen requests permission from the Board to sign the Ayres Animal Shelter contract, NYS Department of Transportation letter regarding permits and working next to state highways, and the contract with the Village of Canajoharie for \$1.00 for payment of snow removal on the front sidewalk

Motion by Councilman Toomey to sign the above contracts/letter, **seconded** by Councilperson Burgess, **all in favor, unanimous Ayes, carried**

Agreement for expenditure of highway moneys

The Highway Superintendent brought the annual agreement for expenditure of highway moneys to the Council for signature approval.

Supervisor Allen sets reevaluation bid openings on January 15, 2015 at 7:30pm. Purpose of special meeting is to select company(ies) to interview

Supervisor Allen hopes to have an additional BAR member appointed by the special meeting

Supervisor Allen will research about repealing the local law which overrides the tax cap; Councilman Young concerned about hurting the taxpayers in the next budget

Supervisor Allen and Superintendent Hodge are investigating mobile software for the Superintendent to use; Also, looking into a digital time clock to improve record keeping

Supervisor Allen presents letter of concern about compressor station to be built in the Town of Minden by town resident, Anne Norman

HIGHWAY

Superintendent Hodge requests that the Board consider splitting the cost of the purchase/maintenance of a wood chipper with the Town of Minden Highway Department. Minden purchased the chipper from Auction International for \$7,100.00. If both Minden and Canajoharie share the services, Minden stores it, and Canajoharie cost is only \$3,550.00.

Motion by Supervisor Allen to authorize shared purchase of wood chipper with Town of Minden, **seconded** by Councilman Toomey, **all in favor, unanimous Ayes, carried**

Superintendent Hodge requests the purchase of a 10ft sander for the new truck; [He would put the 7ft sander on the pickup truck, if approved]. First bid in the amount of \$7,785.00 for 9ft spreader; Second bid for \$7,585.00 for 10ft model; Councilman Young concurs as long as it is in the Highway budget for purchase

Motion by Councilman Young to purchase 10ft spreader in amount of \$7,585.00, **seconded** by Councilperson Burgess, **all in favor, unanimous Ayes, carried**
