The Town Council met for a regular monthly meeting at the Town Hall building, 12 Mitchell Street, Canajoharie, New York.

Present: Supervisor Herbert Allen, Councilpersons: William Armitstead, and John Toomey; Bookkeeper Amy Kretser; Highway Superintendent David Hodge; Councilman-Elect John Peruzzi; County Legislator Roy Dimond; Attorney Charles Tallent, Diane and Paul Corso; Councilman Rodney Young and Councilwoman Judith Burgess not in attendance

7:30pm- The meeting was opened by the Supervisor and the evening's agenda was presented

On a motion by Councilman Armitstead, seconded by Councilman Toomey, the agenda was approved, all in favor, and carried

On a **motion** by Councilman Toomey, **seconded** by Councilman Armitstead, the October meeting minutes was **approved**, **all in favor**, **and carried**

7:31pm-Public Hearing Regarding the proposed 2016 Town Budget; No one from public spoke **Public Hearing closed** at 7:32pm

7:32pm-Public Hearing regarding the proposed Time Warner Franchise agreement; No one from public spoke

Public Hearing closed at 7:33pm

Public Comment: Paul and Diane Corso requests a commitment letter from the Town Board for "grandfathering" property at 975 Dygert Road in order to build on that land that previously was owned by Mr. Corso's grandfather in the 1940; The property is only 1 acre, Town Zoning Law requires new buildings on 3 acres

- -Supervisor Allen informs the Corsos that the land was sold at County Auction, therefore, it does not apply for the "grandfather law." The Town Attorney advised him that when the property was sold at the auction, the property was sold "as is"
- -Charles Tallent, Esq. informed the Board that the current owner had the taxes reduced because the house is in such bad shape; the current owners were also told they could build as long as one wall of the footprint existed in the new construction;
- -Attorney Tallent asks the Board to make an exception to build on this land, if a commitment is not obtained, the sale of the property will fall through; The buyers are ready to do demolition immediately, then build within a couple of years
- -Supervisor Allen informs Mr. Tallent that the Planning Board is concerned about the property being in wetland, how the water and septic will get to the house, and that the house has to be the same original size
- -Councilman Armitstead suggests the Zoning Board of Appeals
- -Ms. Kretser informs Mr. Tallent that the next Planning Board meeting is scheduled for the fourth Monday in January, unless the Chairman of the Planning Board deems it necessary to convene beforehand
- -David Shults is the Zoning Board of Appeals Chairman

- -Ms. Corso indicates the building plans are for a small log cabin
- -Superintendent Hodge states there is a water problem on that property
- -Supervisor Allen instructs Atty. Tallent and his clients that the Planning Board and/or the Zoning Board of Appeals are the ones who need to give permission to build on that property, not the Town Board

In the Matter of Granting of a Cable Television Franchise Held by Time Warner Cable Northeast LLC in the Town of Canajoharie, County of Montgomery, New York

Sponsor: Supervisor Herbert Allen Second: Councilman John Toomey

An application has been duly made to the Board of the Town of Canajoharie, County of Montgomery, New York, by Time Warner Cable Northeast LLC ("Time Warner Cable"), d/b/a Time Warner Cable, a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 120 Plaza Drive, Suite D, Vestal, New York 13850 for the approval of an initial agreement for Time Warner Cable's cable television franchise for fifteen (15) years commencing with the date of approval by the Public Service Commission. The Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings.

A public hearing was held in the Town of Canajoharie, New York on November 12, 2015 at 7:30P.M. and notice of the hearing was published in the Recorder on November 2, 2015.

NOW THEREFORE, the Board of the Town of Canajoharie finds that:

- 1. Time Warner Cable has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Time Warner Cable has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and
- 3. Time Warner Cable can reasonably meet the future cable-related community needs and interests, taking into account the cost of meeting such needs and interests.

BE IT FURTHER RESOLVED that the Board of the Town of Canajoharie hereby grants the cable television franchise of Time Warner Town of Canajoharie for fifteen (15) years commencing with the date of approval by the Public Service Commission and expiring fifteen (15) hence.

BE IT FURTHER RESOLVED that the Board of the Town of Canajoharie hereby confirms acceptance of this Franchise Renewal Agreement.

The foregoing having received a unanimous vote and was thereby declared adopted.

Supervisor Allen informs the Board there will be a meeting with MAS and Town Sole Assessor on December 1, 2015 at 10:00am to discuss the progress of the Town-wide reevaluation

Highway Superintendent- Suggests to the Town Board that a new truck should be purchased, as the majority of the highway equipment is old and constantly need repair. Would cost the Town less in the long-run due to the repair costs of the equipment; Presented to the Board estimates for a 2015 truck spec for 20 years: \$120,000.00 or \$131,000.00 with automatic transmission; 13ft stainless steel plow bid: \$500.00

- -Also informs the Board that the County is using GPS pilot programs to monitor the movements of the highway departments
- -Supervisor Allen responds that the Town has an outstanding \$108,000.00 bond for the last truck purchased, and a new truck purchase was not included in the 2016 budget; In addition to the outstanding truck bond, there is an outstanding bond for the Town-wide re-evaluation project; Suggests not to do make any decisions about purchasing a new truck until January

Motion to table discussion/decision for new truck purchase until the other two Councilmen are present by Supervisor Allen, seconded by Councilman Toomey, all in favor, ayes, carried

Supervisor Allen informs the Board that sales distribution is down a bit
