- -Motion to declare a negative declaration on the proposed solar law updates by Councilman Peruzzi, seconded by Councilman Armitstead, all in favor, ayes, motion carried
- -Motion to Refer to the Montgomery County Planning Board Proposed Local Law #2 of 2017 by Councilman Toomey, seconded by Councilman Peruzzi, all in favor, ayes, motion carried

- -Supervisor Vroman introduces himself as he has been newly appointed by the Town Board as Town Supervisor
- -Supervisor Vroman describes the meetings he has attended including county-wide shared services initiative and farm land use/programs;
- -He informs the Board that Montgomery County Executive, Matthew Ossenfort, requests a meeting with the Town Board to discuss the shared services initiative;
 - -Supervisor Vroman schedules a special board meeting for May 18, 2017 at 7:30pm
- -Informs the Board that the Town has received a letter and check in the amount of \$4,747.41 from NYS Department of Taxation and Finance for meeting the requirements for aid for cyclical reassessment on the Town's 2016 assessment roll; The letter also commends the Town's Sole Assessor, Charlene Ruszkowski, for a job well done

HIGHWAY SUPERINTENDENT- Old loader is in bad shape—Highway Dept. has 2 loaders, 1974 and 2006; Proposes to the Town Board municipal leasing for a new loader; Presents NYS bids for Volvo and CAT loaders with the different options for leasing: 2, 3, or 5 year plans;

- -Superintendent Hodge would like to put the old 1974 loader on Auctions International
- -Expresses the importance of loaders to a Highway Dept. and would like approval for a lease by the June meeting
- -Town Board agrees to discuss the issue again at the scheduled special meeting May 18th
