Motion for public hearing to be held August 10th for or against proposed Local Law #3 to Override NYS 2% Tax Cap by Councilman Young, seconded by Councilman Toomey, all in favor, ayes, passed

Supervisor Vroman- the County Legislature foreclosed on the Beech Nut property -Continuing discussion regarding the County's proposed consolidation efforts -Gave the Board information on how to find Mohawk Solar project's progression on the NYS Department of Public Service website

HIGHWAY SUPERINTENDENT- informs the Board that the CAT salesperson came back with a late lower offer *after the fact* of Board approval of the Volvo loader -DB account is -\$22K, however, in final stages of FEMA reimbursement to replenish the account; but still need some funds currently in the DB account to complete road projects -Also approx. \$1,800.00 short in new equipment
