# TOWN OF CANAJOHARIE MONTGOMERY COUNTY

## August 10, 2017

The Town Council met for a regular monthly meeting at the Town Hall building, 12 Mitchell Street, Canajoharie, New York.

**Present:** Supervisor Peter Vroman; Councilpersons: William Armitstead, John Peruzzi, Rodney Young; Councilman John Toomey not present; Bookkeeper Amy Kretser; Highway Superintendent David Hodge; Sole Assessor Charlene Ruszkowski

The meeting was opened by the Supervisor at 7:30pm, and the evening's agenda was presented

On a **motion** by Councilman Armitstead, **seconded** by Councilman Peruzzi, the **agenda** was **unanimously approved** 

Before the opening of the public hearing, Supervisor Vroman read the following:

The Town Council of Canajoharie <u>has no intention of budgeting</u> over the 2% Tax Cap imposed by the State, however, the Town Council is pursuing to override the 2% Tax Cap imposed in General Municipal Law 3-c in case the need arises. This proposed local is passed in case it is discovered during the budget process that it may not be possible for the Town to stay within the constraints of this imposed tax cap and still offer valuable services to the people of the Town. The local law overriding the 2% tax cap would then be rescinded after the budget is passed if it is not used. This procedure has been the practice of the Town since the tax cap inception in 2011. Since then, the Town's budgets, to my knowledge, have not gone over the 2% cap.

Further, at this point in the precursor stage to the budget process, there is no indication that the Town's budget will go over the 2% tax cap. However, the Town must prepare for any unforeseen scenarios, that is why the Town exercises its' authority pursuant to subdivision 5 of General Municipal Law 3-c to override the tax levy limit by adoption of this proposed local law.

On motion by Councilman Armitstead, seconded by Councilman Peruzzi, the July 2017 regular minutes were unanimously approved

**Public Comment-** Discussion of Mohawk Solar, LLC public information meeting held August 9<sup>th</sup> at the Canajoharie Fire House; Concerns raised that not everyone was notified of the meeting by the company; Numerous requests made to have another public informational meeting with the solar company and also a public meeting to explain Article 10; Solar farm concerns discussed

-Supervisor Vroman explains that Mohawk Solar mailed over 3000 letters to property owners that reside within the 1-2 mile radius of the actual project site, so there is a possibility that some did not receive the notification letter, especially if they are not within the project area range; He cannot

speak regarding the company's compliance with notification of the meeting, but explains that the company is obligated to follow the rules set forth in NYS Article 10, which includes the before mentioned notification letters, newspaper notices, etc.;

-Question arose regarding Wintergreen Park, however, the question needs to be addressed by the Village of Canajoharie as the Town does not maintain the Park

## RESOLUTION #17 of 2017 OVERRIDING STATE 2% TAX CAP IMPOSED ON TOWN

WHEREAS, the New York State Assembly and Senate each passed a bill that imposed a 2% tax cap on the levy of municipalities and school districts, and

WHEREAS, Governor Cuomo signed this 2% tax cap into law on June 30, 2011, and

WHEREAS, it may not be possible for the Town to stay within the constraints of this imposed tax cap and still offer valuable services to the people of the Town, and

WHEREAS, included in the said 2% tax cap law is language that authorizes the Town, by the affirmative vote of at least 60% of the Council, to override the said cap, and

WHEREAS, the Town has published legal notices and held a public hearing on August 10, 2017 at 7:30pm to hear the public, for or against Local Law #3 for 2017, which will override the 2% tax levy limit established in General Municipal Law 3-c,

RESOLVED, that the Canajoharie Town Council hereby exercises their authority and overrides the State imposed 2% tax cap on the levy in order to fund valuable services to the people of the Town.
