**TOWN SUPERVISOR-** last 2017 quarter sales tax check received; Mentions letter from Atty. Ayres re: Budd Rd

-Discusses email received from the Town Assessor re: disabled exemptions

Councilman Young reports on the Mohawk Solar project; Intervenor attorneys have listed 39 stipulations to present to the Public Service Commission (PSC); The solar company requested a variance from ZBA and it was denied at this time; Town's goal is to be sure the solar company adheres to the Town's rules and regulations

-Bookkeeper Kretser will handle the processing of the intervenor bills received by the Town ie: completing the vouchers to send to the intervenor judges so the attorneys and engineering firm get payment

-There is still uncertainty as to what will happen with assessments on the land, assumption that it will be changed to commercial

-one of the Town's main concerns are the Town roads and potential damage or wear to them from construction vehicles

-Solar company may need to build a storage shed for equipment, or rent a space in the village, nothing confirmed

-Intervenor Engineers would like to ask for more money, however, the additional funds would come from the solar company; The intervenor engineers requested that the Town hire a lead engineer company to oversee the project, however, it is the Town's understanding the intervenor engineering company is supposed to be doing that

-The process is in the preliminary stages, the permit has not been applied for, studies are being done

**HIGHWAY SUPERINTENDENT-** back-up loader needs a new transmission, the estimate for repair is \$31,787.44 from Vantage Equipment; the loader is not usable without a transmission; the 1967 grader is not workable either, it has been 10-15 years since last tire change, grader is used in the summer; 2009 truck had a \$7K repair

-Motion to pay for the repair of the back-up loader in the amount of \$31,787.44 by Supervisor Vroman, seconded by Councilman Peruzzi, all in favor, ayes, carried received two bids for new pick-up trucks; Discussion as to the process of turning over pick-up trucks every two years to keep the repair costs low or non-existant -Motion to buy the two trucks, 2018 550 reg cab chassis 4x4 and 2018 tradesman crew cab by Councilman Armitstead, seconded by Councilman Toomey, all in favor, ayes, carried -Low on sand, will hold off as long as possible for reordering more

#### TOWN CLERK

Informed the Board that the Town warrant in the amount of \$472,087.00 has been fulfilled and given to the Town on Jan. 22<sup>nd</sup>; Anticipate giving the County their January tax collection check next week

**BOOKKEEPER-** informs the Board that the Homkey Estate release has been signed by the widow; will give check to her attorney, Atty. Abdella, with approval from the Board—the Board is in full agreement

-working on the dental coverage with CSEA; awaiting the contract from CSEA for signature
