Whereas, the Town of Canajoharie Town Board are concerned for the safety of all children attending school, pedestrians, wildlife and motorists along aforesaid road, and

Whereas, Route 163 is a State Highway, and

Whereas, an Amish schoolhouse is located at 1719 State Highway Route 163,

Whereas, the Town Supervisor has requested to the Canajoharie Town Board that the speed limit on Route 163 between mile markers 163/2501/1085 and 163/2501/1088 be reduced from 55 miles per hours to 35 miles per hour,

Whereas, the Town Supervisor has requested to the Canajoharie Town Board that the current passing zone located in front of the Amish school be re-designated to a "No Passing Zone" with appropriate double solid line road marking in from of the schoolhouse between mile markers 163/2501/1085 and 163/2501/1088,

BE IT NOW RESOLVED: The Town Board hereby requests that the Department of Transportation, pursuant to Section 1622.1 of the New York State Vehicle and Traffic Law, to establish a lower maximum speed at which vehicles may proceed on Route 163 between mile markers 163/2501/1085 and 163/2501/1088, and to re-designated that portion of Route 163 in front of the schoolhouse as "No Passing" with double solid line road markings.

RESOLUTION # OF 2019 **[Tabled]** Setting Fees for Solar Facilities in the Town of Canajoharie

WHEREAS, Local Law #2 of the year 2017 was filed with the Department of State on June 16, 2017, which establishes Town-wide solar energy systems rules and regulations for permitting and installation of utility-scale solar collector systems, as well as rooftop, flush mounted, ground mounted racks and freestanding solar collectors,

WHEREAS, the Local Law did not set the fees for solar facilities, but left same to be set by resolution of the Town Board,

NOW THEREFORE BE IT RESOLVED, that the fee for commercial solar projects shall be \$250.00 per acre for each acre used for the construction of solar panels, fencing, right-of -ways, roads, buildings, etc. during the project in the Town; And in addition thereto, the applicant shall reimburse the Town for all costs and professional services, including but not limited to, engineering and legal fees incurred by the Town associated with the application, permit, or review as deemed necessary by the Town, and be it further,

RESOLVED, that the fee for residential solar projects in the Town shall be based upon the estimated cost of the project as follows:

Estimated cost of project	Permit Fee
Under \$500.00	\$20.00
\$500-\$25,000.00	\$25.00
\$25,000.00 and up	\$40.00
