The meeting was opened by the Town Supervisor at 7:30pm, and the evening's agenda was presented

On a motion by Supervisor Vroman, seconded by Councilman Toomey, the agenda was unanimously approved

Public Comment- Representatives from the Canajoharie Little League present: Chris Yacobucci and Alison Kretser; Ms. Kretser describes all of the fundraiser they had throughout the season; Opening day was a huge success and brought a sense of community; Many games were cancelled throughout the season due to inclement weather

-Chris Yacobucci describes the main field has major drainage issues; the Village is assisting with installing a new drainage tile into Garlock Street in August

-Ms. Kretser describes the drainage issues and accessibility issues at Wintergreen Park; the Village is assisting them with a grant proposal; the grant proposal requires the recipient to contribute 20% to the project; the Little League is asking the municipalities to contribute to their capital funds account to help defray the cost; They're 5-10 year goal is to fit 3 fields within Wintergreen Park -Currently, the Little League uses the ball park in Ames and at Wintergreen Park

for practices, and the main field for games
