New Business- Supervisor Vroman schedules tentative budget workshop for September 24th at 7:30pm

- Supervisor has received proposed fire contract budget amounts from the Ames Volunteer Fire Department and Canajoharie Volunteer Fire Department, but not from the Minden Volunteer Fire Department; Should receive Minden's next week
- Supervisor plans on meeting with the Arkell Foundation next week
- Supervisor plans on meeting with the County grant writer at some point
- Barton & Loguidice has reached out regarding the possibility of representing the Town as intervenor engineers regarding the Article 7 power line upgrade project

Public Comment- Representatives from Lamont Engineering: Chris Yacobucci, Milan Jackson, and Brenden Becker provide the Board with a presentation about the proposed new Town garage and what services their company provides to municipalities regarding projects of this nature; Lamont specializes in municipal construction and engineering services, and has current and past experience with town garage constructions; They also can assist the Town in securing funding, although not many available grants for highway garages; The reps understand that if the Town is able to handle some parts of the project ie: site work, the cost is more effective for taxpayers

-Meeting is scheduled at the site for September 25 at 9:00am with the Highway Superintendent and Lamont representatives; Town Supervisor and Councilman Young will attend -Lamont representatives briefly explain the permissive referendum process

Mohawk Solar updates- Bookkeeper Kretser [also ZBA and Planning Board Secretary], indicates that the ZBA is in the process of setting up an informal meeting with Mohawk Solar in which they will present their area variance applications for the project; No date has been set

Bookkeeper Kretser indicates there are two subdivision applications before the Planning Board

Bookkeeper- there is a small amount of money left in the G fund---need to borrow from Highway funds which will be paid back to the Highway fund; Money is still set aside for the building fund; Budget amendment as stated in bookkeeper report
