The Town Council met for a public hearing on the preliminary budget for 2020 and regular monthly meeting, 12 Mitchell Street, Canajoharie, New York.

Present: Supervisor Peter Vroman, Councilpersons: William Armitstead, Rodney Young, John Peruzzi, Sr.; Highway Superintendent Timothy Jones; Bookkeeper Amy Kretser; Councilman John Toomey, Jr. not present

The hearing/meeting was opened by the Town Supervisor at 7:30pm, and the evening's agenda was presented

On a motion by Supervisor Vroman, seconded by Councilman Armitstead, the agenda was unanimously approved

7:32pm- Public Hearing on the 2020 Preliminary Budget; no comments from the public in attendance

7:35pm-Public hearing closed

7:35pm-regular Board meeting commences

On a **motion** by Supervisor Vroman, **seconded** by Councilman Peruzzi, the October regular meeting minutes **were unanimously approved**

Public Comment- Jay Summerson questions the Board as to when the last time the Board and Town Supervisor received a raise in salary; he states that the Board and Supervisor are underpaid

-The Supervisor and the Board responds indicating that the Town's budget is always very tight, and raises are given to other Town employees before they receive any; The Board sincerely thanks Mr. Summerson for his comments

-Mr. Summerson then has questions re: Mohawk Solar Article 10 project

-Supervisor Vroman responds explaining that the process is being watched very carefully by numerous NYS and Federal government agencies pursuant to the Article 10 process; Currently, Mohawk Solar has its' variance applications before the Town's Zoning Board of Appeals, the next ZBA hearing on their variance applications is scheduled for November 13th

-Mr. Summerson asks about the upcoming new Town Garage building project, how much it will cost, etc.

-Councilman Armitstead explains that new Town Garage project is in its' infancy and not sure of the cost as of yet; Board explains that they are in the process of signing an agreement with Lamont Engineers to start the preliminary stages of the project

Supervisor Vroman- asks the Board if more discussion is needed regarding the preliminary budget; No further discussion

WHEREAS, Lamont Engineers scope of services shall include the preparation of conceptual floor plans, preliminary site plan, a preliminary project budget, final design and related details, a project manual and specifications to be used by the Town for Public Bidding,

IT IS HEREBY RESOLVED, that the Canajoharie Town Board accepts Lamont Engineering's proposal and authorizes the Town Supervisor to sign the letter form of agreement.

-Supervisor hoping to attend next meeting being held in December re: former Beech Nut site **Mohawk Solar Updates-** ZBA is holding an additional public hearing/meeting on November 13 regarding Mohawk Solar variance application

Highway Superintendent- the extension to the Town garage to fit the new truck and plow complete, the project cost \$8,000.00 with most of that cost being for the vermiculite abatement

-the Town Highway Dept. is all set for winter

-working on the Happy Hollow Road bridge

-asks the Board for permission to replace the 25 year old sweepers, not worth putting money into repairing it; Replacement sweeper would cost \$6,800.00, be 8 feet wide, would like to purchase out of 2019 budget, and sell old sweeper on Auctions International

-Motion to purchase new sweeper as requested by the Highway Superintendent by Supervisor Vroman, seconded by Councilman Peruzzi, all in favor, ayes, carried

Town Clerk- restates to the Board her resignation, last day as Clerk November 18th; Expresses her gratitude to the Board and pleasure working with them during her terms

Town Bookkeeper- Town books are keeping afloat
