**Public Comment** – Adam Ellis, Avangrid, was in attendance to provide an update on the solar project. He stated they are working on Permit issues and are in discussions with National Grid. They anticipate breaking ground the first quarter of 2021. He further commented that the Governor is working on changing Article 10, designed for oil and gas drilling, to Article 23, a platform for renewables.

# Power Line Upgrade Update

Mr. Vroman noted he had a meeting in Fonda regarding the power line upgrade. He stated they have decided to begin in the East and work toward the West; therefore, work in the Town of Canajoharie is a long way off – most likely 2021.

Kurtis Hohensheldt, a resident of the Town, was recognized by Mr. Vroman as having entered the meeting and was asked the nature of his business. After a brief discussion, it was determined that he should attend the upcoming Planning Board meeting as the Town Board meeting is not the place to obtain the answers to his questions.

## Snow and Ice Contract for 2020

Mr. Vroman stated he met with Eric Mead, Montgomery County Public Works Commissioner, regarding the renewal of the Snow and Ice Contract for 2020. All Town Highway Superintendents are being asked to provide information to aid in the negotiations.

### Mohawk Solar Historical Grant

Mr. Vroman noted that Mohawk Solar likes to provide historic restoration in the towns they are doing business in. To that end, he has asked that money they provide go to restoring the Town Hall at 12 Mitchell Street, as it is in need of a roof, boiler, paint and shutter replacement. It was also noted that there are small, unattended cemeteries within the footprint of the Town. The Town Clerk will research the location of these cemeteries and provide the Town Supervisor with a list.

#### **Planning Board**

Mr. Vroman stated he attended the last Planning Board meeting and that it is working well without a Chairman, which, at this point, has saved the Town 2 months of salary on the position.

#### Highway Superintendent – New Truck

In Tim Jones, Superintendent of Highways, absence, Mr. Vroman presented the Councilmen with information regarding trading in two smaller trucks owned by the Town and purchasing new ones. It was determined that we should focus on the smaller pick-up truck only and revisit trading in the dump truck next year at, the earliest. The Councilmen asked for more information (i.e., current trade-in value of the old pick-up, does the trade-in include the plow, how long will the new truck take to arrive) before proceeding with this matter.

Whereas, savings to the Town is anticipated to be \$1948.28 the first year and \$2762.28 each year after,

Now, therefore, be it RESOLVED that: Town of Canajoharie Councilmen authorize the Town Supervisor to sign the Service Agreement, entering the Town into a 60-month contract with TPX Communications.
