State Board on Electric Generation Siting and the Environment for a Certificate of Environmental Compatibility and Public Need Pursuant to Article 10 of the Public Service Law to allow Mohawk Solar LLC to construct and operate the facility and,

Whereas, the Towns have participated fully in every phase of the review of the Project under Article 10 of the Public Service Law using intervenor funds awarded for that purpose, additionally the Zoning Board of Appeals of the Towns issued area variances for the Project,

Survey and Topography Study

Mr. Vroman stated that Chris Yacobucci is looking forward to getting his copy of the survey for the Town Garage property. Mr. Young noted it would be sent out as soon as it is finished.

Mr. Vroman took time to thank the Town Clerk, who has worked full-time throughout the Tax Season despite the State of Emergency, to collect taxes and the effort is appreciated.

Mr. Peruzzi brought up the fact that Richardson's is going out. A letter from them stated that on March 9, 2020, the assets of Richardson Foods, Inc. and its Richardson Brands company were foreclosed upon and sold by its senior secured creditor, and that as a result, the company is unable to pay its outstanding obligations. It was questioned as to whether or not their taxes had been paid. Following research by the Town Clerk, it has been determined that the 2020 Town and County taxes had been paid in full on March 12th.

Highway Superintendent

As the meeting was being held via teleconference, the councilmen asked to table the New Truck until everyone can meet face-to-face.

Whereas, Mr. Jones, Highway Superintendent, has taken 5 used pieces of equipment, belonging to the Town, to auction and received bids, as follows: Mower (\$10900.00); 3 Point Hitch (\$550.00); Nose Plow (\$62.50); Front Plow (\$920.00); and Hot Water Pressure Washer (\$230.00), and

Whereas, the Town Councilmen have approved accepting the bids on the Old Mower (\$10900.00), 3 Point Hitch (\$550.00) and Hot Water Pressure Washer (\$230.00), for a total of \$11,680.00, and asked to hold off on selling the Nose Plow and Front Plow for a better price, and

Whereas, Mr. Jones has asked the money earned be put back into the parts account, as we have currently spent \$1200 in repairs to the Grader,

Now, therefore, be it RESOLVED that: the councilmen have approved amending the budget to increase Revenue Code DA2665-Sale of Equipment by \$11,680.00 as well as Revenue Code DA5130.4-Machinery Contractual. This accounts for the revenue on the sale of equipment to offset some of the cost to repair the grader.

Mr. Jones concluded by asking when employees could go back to work. Mr. Vroman sated he would contact Montgomery County Board of Health and see what the guidelines are. Following the meeting, Mr. Vroman received correspondence from the County, stating "Essential work, repairs, outages, emergency work is all fine to continue but day to day maintenance can be put on hold as of now. Mowing grass, since it is tick season and mosquito season is considered essential and allowable, as there is only 1 person at that task."

Town Clerk

Mrs. Jewell stated that Tax Collection for 2020 had ended and the town received \$500,097.00, as well as \$6198.86 in Penalties.

Town Bookkeeper

Mr. Kretser noted we have money again and further stated that the Planning Board met and resolved the Dingman sub-division. She noted it has been decided that, during the State of Emergency, there will be no more Planning Board meetings scheduled. Mike Muhlebeck, acting Planning Board Chairperson, will research issues as they arise and schedule meetings as needed; however, the end of May would be the earliest he would begin scheduling meetings. Mr. Vroman commented that the Town is paying Mr. Muhlebeck the Chairperson salary as long as he is the acting Chairperson.
