## **Town Supervisor**

Mr. Young noted that resident Jay Summerson approached him regarding funding for the town, stating "there is money out there we could get." Mr. Young will research opportunities for the Town.

Mr. Young stated an informal analysis results are in for the well drilled for the new Town Garage, showing it is very salty. The informal analysis results will be sent to Montgomery County Public Health for a determination and the water will be retested. Mr. Armitstead, who witched for the well, has discovered you can witch for good/bad water; therefore, he went back and tried again and now believes he found a good water source. Once the test results are back, the option of drilling another well on the property will be explored, using the casing from the well recently drilled, to save money. Mr. Jones suggested the possibility of building a pond and using it for a fire resource as well.

Mr. Young has spoken with Terresa Bakner, Town Attorney for the Mohawk Solar project, who stated they are ready to begin the tree clearing process. Mr. Young has a meeting scheduled with Scott McDonald to discuss the Town fees for the project, and a positive outcome looks encouraging. The Town may have to pay a small portion from the fees for a specialized code enforcer.

### Highway Superintendent

Mr. Jones, after attending an Emergency Management meeting, stated it was suggested Towns reach out to retirees to work part time in the event COVID-19 creates staffing issues. The Board agrees paying experienced retirees \$18.00/hour is a viable option.

Mr. Jones noted the transmission went out on the pick-up truck used for plowing, days before the warranty expired and it will be weeks before we can get the necessary part.

Regarding the in-stock Gradall, Mr. Young will call Doug Landon, Town Attorney, for clarification on the proposed lease where we take possession immediately and begin payments 1 year later, and Ann Jackson, a finance representative. In the meantime, the County Gradall can be used.

Mr. Jones stated he has accepted the floor plan for the garage. He suggested we contact Montgomery County for assistance with grant writing for funding. Mr. Young has a meeting with NBT Bank regarding funding, who will loan up to 3 million dollars.

A discussion ensued regarding putting the new Town Garage project on pause due to COVID-19 and from the prospective of the Town taxpayers. It was noted that it will take up to a year before the majority of the project begins and we will assess how COVID-19 is affecting the Town's income and Taxpayers as we move forward.

### Town Clerk

Mrs. Jewell noted the Town's profit for selling hunting licenses for the past season was \$135.43 (5% of the total sold). She further stated she will be able to write a check in the upcoming week to the Town for its total share of Town and County taxes collected.

#### Town Bookkeeper

Ms. Kretser stated the General Fund is hanging in there. The Highway fund is in good condition; therefore, she has had to borrow from it. She closed by noting the Planning Board had approved the Hohenshelt subdivision. The question of a Board Chairperson was discussed, and that Michael Muhlebeck has been assuming the duties until one is named.
