Call to Order

The meeting was called to order by Mr. Young, Acting Town Supervisor, at 7:30 PM, with the Pledge of Allegiance and after noting that some Town Council members and some members of the public are still utilizing teleconferencing to attend the meetings, as the country is in a state of emergency due to the COVID-19 virus, and the Open Meeting Law has been relaxed during this time (as per Executive Order 202.48 COVID 19 Disaster Emergency).

Mr. Young reinforced the regulation about wearing masks in public.

Accept the March 2021 Meeting Minutes

A motion was made by Mr. Young, seconded by Mr. Armitstead, that the minutes of the March 2021 meeting, as submitted by the Town Clerk, be approved. All in favor ayes, carried.

Recognition of Citizens Present

The Board recognized Les Hassan, Town of Canajoharie Code Enforcement Officer, who made the Council aware that, since Governor Cuomo signed a bill legalizing recreational marijuana, the Town and Planning Board need to discuss how Canajoharie will be affected.

The Board recognized Ronald Dievendorf, running for the open seat of Town Supervisor, who came to observe.

The Board recognized Benny Goldstein, who introduced himself, noting that he is running for the Town Supervisor position.

The Board recognized Scott McDonald, Avangrid, who updated the Council on the Town Solar project. A notice has gone out to landowners and Montgomery County that work is anticipated to begin, clearing trees from November until January 2022 with civil work to start in 2022 and last through May 2023.

Mr. Young asked when permit applications will be submitted and it was noted it is laid out in the Road Use Agreement, which states as soon as the agreement is executed or the notice to proceed is issued, whichever is first. Mr. Young questioned if there are restrictions on the use of the money and Mr. McDonald assured there are not. Lastly, it was noted that \$25000 to be used to hire a compliance officer to oversee the project will be split 80/20 between the Town of Canajoharie and the Town of Minden.

Court Bailiff

The Honorable Judge Gizzi, Canajoharie Town Justice, asked the Council to consider hiring someone qualified and with the proper credentials, outside of the Sheriff's Department, to act as Bailiff on Town Court nights. The cost would be \$50/month with an additional \$20.00/hour if needed more than 2 hours, as opposed to \$45.00/hour for the Sheriff's Department employees we currently hire, which also takes an officer off the road. All in favor ayes, carried.

Judge Gizzi also wanted the Council Members to be apprised that he is looking into an updated security system, which may require Town funds to pay for a portion, yet to be determined. The system would include tying into the Fire and Police Department in the case of an issue afterhours. Mr. Goldstein stated he is good with installing cameras and is happy to help if there is a need.

Well Drilling

American Well Drilling has submitted a proposal of \$8822.29 to dig a second well for the new Town Garage. If they can reuse the casing from the first well dug, they will give the Town a credit for the amount that can be used. It is agreed that the water situation needs to be settled before placement of the building can be agreed upon.

Mr. Young noted, with regard to the new Town Garage, the next step in the process would be a Bond resolution and he has been talking to NBT Bank and Town Attorney, Doug Landon, in preparation. NBT Bank suggests the Town hire a financial advisor; who would be able to ascertain how much the cost of the project will increase Town taxes; Mr. Young will look into this further with the hope of having more information at the next Town Council meeting. It was suggested that Mr. Young reach out to Montgomery County Executive Matthew Ossenfort to see if there might be any financial assistance available. It was also noted that putting information about the new Town Barn on the Town website will help residents get the information they need.

Town Clerk

The Year-to-Date Building Permit report for First Quarter 2021 was submitted to the Council members, showing a total of 3 at a total cost of \$200.00.

Town Bookkeeper

Ms. Kretser noted that the Town Financial Books for 2020 have been filed with the State and no issues have been noted. Hard copies were distributed for the Council members to sign. Mr. Dievendorf asked how it was submitted and Ms. Kretser stated manually, not electronically. He also inquired and was told office and highway employees are paid bi-weekly; everyone else, monthly. In closing, Ms. Kretser noted the Planning Board approved a subdivision for Elmer Stoltzfoos.
