Call to Order

The meeting was called to order by Mr. Young, Acting Town Supervisor, at 7:30 PM, with the Pledge of Allegiance and after noting that some Town Council members and some members of the public are still utilizing teleconferencing to attend the meetings, as the country is in a state of emergency due to the COVID-19 virus, and the Open Meeting Law has been relaxed during this time (as per Executive Order 202.48 COVID 19 Disaster Emergency).

Accept the April 2021 Meeting Minutes

A motion was made by Mr. Young, seconded by Mr. Peruzzi, that the minutes of the April 2021 meeting, as submitted by the Town Clerk, be approved. All in favor ayes, carried.

Recognition of Citizens Present

The Board recognized Michael Muhlebeck, Town of Canajoharie Planning Board Acting Chairperson. Mr. Muhlebeck requested the Board consider a resolution enacting a local law placing a temporary moratorium on future Solar Energy Systems. The proposed revised and reintroduced local law would establish a temporary moratorium on the review of solar facilities to give the Town Board sufficient time to evaluate the existing law and to make changes to that law, if warranted. Mr. Muhlebeck requested a 6-month moratorium which will run through November, giving the Board time to observe how the Mohawk Solar project has progressed.
