Barton & Loguidice Agreement

Town Barn Well Drilling

LS Power Grid AC Transmission Line Upgrade Project

Mrs. Jewell further apprised the Council that, year-to-date, the Code Enforcement Officer has accepted applications for 20 building permits totaling \$1125.00 in fees.
