# RESOLUTION #7 of 2022 HEARING FOR LOCAL LAW #1 of 2022, ENTITLED "A LOCAL LAW ENACTING A TEMPORARY MORATORIUM ON SOLAR ENERGY SYSTEMS AUTHORIZED UNDER LOCAL LAW #2 OF 2017"

**Sponsor:** Benny Goldstein, Supervisor **Second:** John Toomey, Councilman

WHEREAS, Local Law #1 of 2021 to extend a moratorium placed on the construction of solar energy systems for a period of six (6) months was passed at a public hearing held on June 10, 2021, but was not filed with the New York Department of State,

**WHEREAS**, the Town Board desires to adopt a local law placing a moratorium on the construction, installation, approval and processing of any application of and for a solar energy system, except for the installation of rooftop mounted solar panels, within the Town of Canajoharie,

**WHEREAS**, Local Law #1 of 2022 entitled "Moratorium on Placement of Solar Systems in the Town of Canajoharie, NY" was presented to the Town Board at a regular monthly Board meeting on April 14, 2022 for said purpose,

**AND WHEREAS**, Local Law #1 of 2022 is intended to place a temporary twelve (12) month moratorium to prohibit the construction, installation, approval and processing of any application of and for the placement of any solar energy system, not to include the installation of rooftop mounted solar panels, within the Town of Canajoharie,

**NOW, THEREFORE, BE IT RESOLVED that:** Local Law #1 of 2022 is hereby passed and a moratorium against the placement of solar energy systems, not to include rooftop mounted solar panels, within the boundaries of the Town of Canajoharie, is hereby put in place for a period of twelve (12) months from the date of passage hereof.
