### Call to Order

The Solar Public Hearing was called to order by Mr. Goldstein, at 6:30 PM, with the Pledge of Allegiance.

### **Recognition of Citizens Present**

The Board recognized Steve Stortecky, Ray Kiefl, Chad Bowerman, Mary Caron, Ron Nilsen and Ann Norman, as they had active concerns about the upcoming Solar Law that they'd like to be addressed before the final law is drafted. Their concerns range from health and wellness testing for both humans and animals, visual assessments, setbacks, property depreciation, cost effectiveness, decommissioning and the impact on well water. The residents' concerns were addressed by Kirsten Dunn during the Public Hearing. Taking all concerns into consideration, the Dunn & Dunn team will make some adjustments to the upcoming law to try to accommodate the issues addressed.

On a motion by Mr. Muhlebeck, seconded by Mr. Peruzzi, the Board will host another Solar Public Hearing to be held prior to our next Town Board Meeting, scheduled for August 10<sup>th</sup>, at 7:15 at the Town Hall Building, to discuss the final version of the Town's Solar Law.

**WHEREAS,** Mohawk Solar LLC has been awarded an Article 10 Certificate by the NYS Siting Board for a solar project located predominately in the Town of Canajoharie;

**WHEREAS,** Mohawk Solar LLC has not commenced construction of the solar project and is seeking to amend the existing PILOT Agreement mentioned above;

**WHEREAS,** Mohawk Solar LLC and the Town Board have reviewed the Term Sheet for PILOT Amendment dated May 31, 2023 and incorporated herein by reference.

**NOW THEREFORE BE IT RESOLVED,** that the Town Board of the Town of Canajoharie approves the Term Sheet for PILOT Amendment dated May 31, 2023 and authorizes the Town Supervisor to sign the Term Sheet.
