Call to Order

Town Supervisor

Mr. Vroman spoke to the Board about continuing work on the Comprehensive Plan for the Town, with the potential of getting in touch with someone regarding zoning grant programs.

Another topic addressed was applying for the Records Management Grant which would help with our records management system and storage. Mrs. Hayes has reached out to the local contact that will assist in grant writing for this project.

Deputy Town Supervisor

Mr. Muhlebeck mentioned that the Residents for the Preservation of the MV Committee has sought legal council and has the potential of gaining intervenor funds to help advocate for their cause.

Mr. Muhlebeck also said that he would like the Board to consider writing a letter to the State in support of housing in the former Beech-Nut site.

Sole Assessor

The State has informed Ms. Ruszkowski that the Town needs to have another re-evaluation of properties, with fill data collection, in 2025 to obtain equity. The Sole Assessor, with aide from a State representative, would need to perform this task. The Board has asked that we go back to the State to ask if we can split the re-evaluation over two years' time, and ask what specific help the State representative would provide, as this is a cumbersome process.
