

# Contribution Limits

## 2024 CANDIDATE CONTRIBUTION LIMITS FOR MONTGOMERY COUNTY (see chart on next page)

### General Election Contribution Limits:

The contribution limit for each jurisdiction applicable to the General Election as indicated opposite each Town, City, County or District listed.

### Primary Limits:

The primary contribution limit applies only when a candidate is in a primary election. This contribution limit is calculated for each political party in each jurisdiction and is listed accordingly below the label for each political party.

### Non-Family vs. Family Contribution Limit:

The non-family limit applies to the vast majority of contributors. Certain individuals related to the candidate (Family) must adhere to special contribution limits and disclosure rules. If a contributor is closely related to a candidate, go here to determine whether the family contribution limit and other special rules apply. The election limit for family members is an aggregate limit from all the candidate's family (defined as a child, parent, grandparent, brother and sister and the spouses of those persons).

Please remember that these limits are for the entire election cycle. Generally, the Election Cycle is either two or four years.
