State of economy - what does it mean for public historians?

- Historians area "core function of government" to maintain an historical record of that government
- It is necessary for historians to look for cost savings and efficiencies present costs/savings simply (e.g. in terms of percentage of overall budget)
- Historians need to conduct a PR campaign on what they do (e.g. go door-to-door, establish relationships/rapport with members of press, etc.) - bottom line: MAKE THINGS INTERESTING FOR PEOPLE

County Historian Kelly Farquhar has been working on a survey of African American life in Montgomery County during the 19th century. Researching the lives of the African Americans who lived here through church records, abolitionist or anti-slavery activity, newspaper accounts, and land records, she has applied for funding through the Preservation League of New York to hire a professional consultant for research and compiling the information for online access. Additional sources include the Richard & Rebecca Evans Foundation and the Heritage & Genealogical Society who have both committed to funding the project.

Dave Manclow, historian for the Towns of Minden and Palatine, has scanned the Myron Saltsman collection of slides and giving presentations to various local organizations as well as our Historians' meeting in June. He brought to the April meeting framed 1868 & 1905 maps of the Town of Minden showing school districts within the town. He also brought along to show an envelope with a stamp advertising the Intermediate Landing Field that used to be located outside of Fort Plain.

Lorraine Whiting, historian for the Town of Charleston, has been busy working on the restoration of the schoolhouse at the junction of Corbin Hill Road and NYS Route 162. Work is coming along nicely.

Ryan Weitz, Fultonville Village Historian, has been working with others in the cleanup of the Hoff-Shelp cemetery in the Mill Point area on the line of the towns of Glen and Florida. He also ordered a new gravestone for the Donaldson family in the Old Fultonville Cemetery. Ryan has gotten a new ledger book and has been entering data from the stones in that cemetery. He has been locating other cemeteries in Glen and identifying them with GPS coordinates. Additionally, he procured a gravestone plaque

through the Veterans' Administration for the grave of Revolutionary War veteran Frederick Visscher and his wife Gazena in the Old Caughnawaga cemetery in Fonda. It was reported at the meeting that Congressman Tonko's office has the form for congressional assistance to look at WWII service records.
