MATERIAL REQUIREMENTS

The material provided shall be crushed stone and consist of clean, durable, sharp, and angles fragments of rock uniform quality throughout, free from thin or elongated pieces, soft or disintegrated stone, dirt, or other objectionable materials.

The stone fill shall meet the requirements specified in Section 620-2 and Table 620-1 Gradation Requirements of the Standard Specifications Construction and Materials of the New York State Department of Transportation Standard Specifications current on the date of advertisement for bid.

If undesirable material is furnished from accepted sources through faulty operation or any other cause whatsoever, the objectionable material may be rejected and no payment will be made for the amount rejected.

DELIVERY

Delivery shall be made at the plant into trucks owned or hired by the County. Bids are also requested on delivery costs for hauling the material from the plant to the project location in trucks owned or hired by the material supplier. All costs of unloading materials into distributors or stockpiles shall be included in the delivery cost. A weight slip is required with each delivery. The contractor must send invoices promptly to the County.

PRICE BID

All bids shall be on standard proposal forms. Bid PRICE PER TON shall be the price per ton loaded onto County trucks at the plant. Bid PRICE PER TON-MILE FOR DELIVERY BY MATERIAL SUPPLIER TRUCKS shall be the additional cost per ton-mile for hauling, by the material supplier trucks, the indicated mileages.

PURCHASES

All purchases will be made based on the price per ton bid plus haul cost. Transportation rates to be used for calculating haul cost for County trucks are as follows:

The County will determine the actual minimum haul miles. Trucks rented by the County will be considered as County owned trucks.

The contractor shall provide said material within 2 days after being notified by the Commissioner of Public Works or his representative.

CONTRACT EXTENSION

The County reserves the right to extend any contract issued, based on this specification, under the same terms and conditions for a one-year period from date of expiration, provided such extension is mutually agreeable to both the County and the Contractor.

AWARD

The Commissioner of Public Works of the County of Montgomery reserves the right to reject any and all proposals, or to waive minor informalities, to advertise for new proposals or to proceed to do the work otherwise, if in his opinion, the best interests of the County will thereby be promoted.

OTHER MUNICIPALITIES

All provisions of this specification and the ensuing contract, including insurance, shall be extended to all municipalities in the County of Montgomery, and work ordered by them, shall be furnished according to their needs at the prices and terms of the contract.
