**Description: Supply and Install Overhead Garage Door Openers**

Intent:

It is the intent of this bid proposal to solicit bids for Montgomery Counties Emergency Management Garage to Supply and Install 18 Overhead Garage Door Openers.

Scope:

Work performed under this bid proposal must include all materials, labor, machinery and equipment required to complete the project.

Qualifications of Bidder:

When requested by the Commissioner of Public Works and/or his designee for projects, the bidder must present evidence of experience, ability and financial standing.

Special Conditions:

All work described must be done solely by the contractor bidding the job, the contractor shall not subcontract for any of the services outlined in the work described.

Mandatory Site Visit:

All bidders are requested to attend a site visit on Friday February 9<sup>th</sup> at 9 A.M. at 200 Clark Drive, Fultonville, NY 12072 with the Montgomery County Commissioner of Public Works and Emergency Management Office staff to have any questions or concerns answered as well as familiarize the bidder with the project.

Davis Bacon Act:

The bidder is informed that they are required to follow the Federal Davis Bacon Act, which requires bidders to pay prevailing wage rate and fringe benefits established by the New York

State Department of Labor at the time the work is completed. The bidder will be required to submit a certified payroll indicating prevailing wage has been paid before any payment will be released by Montgomery County.

Insurance:

The bidder will be required to submit General Liability Insurance and Worker's Compensation Insurance with limits not less than \$1,000,000.00. All insurance certificates submitted must name Montgomery County, 20 Park Street, Fonda, NY 12068 as the additional insured.

Work to be performed:

- Bidder will Supply & install 18 Medium duty trolley garage door openers for 14' garage doors.
- Manufacturer to be Lift Master – Model MT 5011U or Equal
- Successful bidder will warranty all work for a minimum of 1 year from date of completion
- Installation will include everything needed for installation minus electric outlets. This should include but is not limited to, optic sensors, 3 button wall control station, and bracing to secure openers.
- Bidder will supply and program one opener per door
- Bidder will supply and install low voltage wire to optic sensor and 3 button wall control station
- Bidder will supply and program 23 two button, remote garage door openers for two currently installed openers at the Montgomery County Sheriff's Office.

All request for proposal must be submitted to Montgomery County Purchasing Department, Montgomery County Annex Building, 20 Park Street, Fonda, NY 12068, no later than February 22nd at 1:30P.M., sealed and marked RFP 02-24. Bids will be opened and read aloud at 2pm at DPW 113 Park St. Fultonville, NY 12072. Montgomery County has the right to reject any and all bids received.
