In addition to an emailed response, Bidders must acknowledge receipt of all Addenda by acknowledging each Addendum on page 1 of the Proposal. Failure of any Bidder to receive any such Addendum or interpretation shall not relieve such Bidder from any obligation under the Bid submittal. All Addenda so issued shall become part of the Contract Documents.
