

ITEM A-66-23 BULK ICE CONTROL SALT

CONTRACT PERIOD: 3/31/23 - 3/30/24

SCOPE

Under this specification, the successful bidder shall provide Bulk Ice Control Salt for use in ice control and for other highway related purposes. The estimated quantity for this bid item is: 20,000 tons

MATERIAL REQUIREMENTS

Bulk Ice Control Salt shall be supplied as a coarse screened, solid, which upon analysis shall not less than 95% +/- 1% Sodium Chloride (dry).

The Bulk Ice Control Salt shall meet the following material specification (see ASTM Designation D632-99 type 1, grade 1.

Sodium Chloride	95%±
Water Insolubles	0.75% Max
Acid Insolubles	0.50% MAX
Surface Moisture	1.00 Max
Yellow Prussiate of Soda	100 ppm. Max

Test Method: Analysis and product performance evaluations are taken from ASTM D632 AND E534.

ADDITIVES

Bulk Ice Control Salt MAY CONTAIN Yellow Prussiate of Soda which is added to improve caking resistance.

TESTING

The successful contractor must submit results from testing to confirm results from an independent laboratory pertaining to the material specification D632-99 type 1 Grade 1. By neglecting to submit results will cause the disqualification of bidder.

DELIVERY

Bulk Ice Control Salt shall be delivered in bulk shipments to storage units within Montgomery County. Delivery shall be made to any point within Montgomery County.

BASIS OF ACCEPTANCE

Bulk Ice Control Salt may be accepted on the basis of manufacturer's certification that his product conforms to the above specifications. This certification shall reference the invoice numbers associated with each delivery.

PRICE BID

All bids will be on standard proposal forms, as furnished by the County of Montgomery. On his proposal, the bidder shall indicate a bid price per ton delivered. A bid price will also be entered for material picked up by Montgomery County at the vendor's stock pile.

AWARD OF BID

Award of bid will be made to the lowest responsible bidder. The county reserves the right to reject any or all proposals, waive minor informalities, advertise for new proposals, or split the award if in the best interests of the County.

CONTRACT EXTENSION

The County of Montgomery reserves the right to extend any contract issued, based on this specification, under the same terms and conditions for a one-year period from date of expiration provided such extension is mutually agreeable to both County and Contractor.

OTHER MUNICIPALITIES

All provisions of this specification and the ensuing contract, including insurance, shall be extended to all municipalities in the County of Montgomery, and work ordered by them, shall be furnished according to their needs at the prices and terms of the contract.
