POLICY:

BY REWARDING THE INCARCERATED INDIVIDUALS POSITIVE BEHAVIOR, THE MONTGOMERY COUNTY CORRECTIONAL FACILITY HAS CREATED OPPORTUNITIES FOR THE INCARCERATED INDIVIDUALS TO EARN CERTAIN PRIVILEGES.

GENERAL INFORMATION:

1. THE FOLLOWING, ARE PRIVILEGES THAT MAY BE SUSPENDED OR REVOKED, FOR NON-COMPLIANCE OF THE RULES AND REGULATION AS STATED IN THE INCARCERATED INDIVIDUAL HANDBOOK.
 - A. COMMISSARY;
 - B. LEISURE TIME ACTIVITIES (CHESS, CHECKERS, CARDS, ETC.);
 - C. TELEVISION;
 - D. ASSISTANCE PROGRAMS;
 - E. GENERAL LIBRARY (NON LEGAL);

 - F. PHONE CALLS (NON-LEGAL);
 - G. INCARCERATED INDIVIDUAL WORKER PROGRAM;
 - H. OTHER PRIVILEGES MAY BE GRANTED UPON AVAILABILITY.
2. PRIVILEGES AFFORDED TO EACH INCARCERATED INDIVIDUAL ARE BASED ON GOOD BEHAVIOR, PERSONAL HYGIENE AND THE CLEANLINESS OF THE HOUSING UNIT AND LIVING AREA.
3. INCARCERATED INDIVIDUALS HOUSED IN SPECIAL HOUSING (DISCIPLINARY REASONS) WILL RECEIVE RESTRICTED PRIVILEGES THAT ARE BASED ON THEIR DISCIPLINARY SANCTIONS.
