Montgomery County Corrections Visitation

Due to Covid 19 we are following all CDC and DOH guidelines for the Correctional Facility. Due to covid restrictions each individual will be allowed 1 Hour of noncontact visit per week. You must use the hour you signed up for. **No individual will receive a visit that is not on the time slot requested. Visitors must follow all Covid 19 protocols. Remember to have your visitor arrive 10 minutes early for processing any later and they will be turned away.**

- 1- Visits will be non-contact
- 2- Visitor must wear a mask you may take them off in the visitation room.
- 3- 2 visitors per Inmate this includes children.
- 4- Must use Hand Sanitizer before and after each visit.
- 5- Failure to comply with temperature scan or any if any signs and symptoms exist, they will be asked to leave
- 6- Must provide contact tracing information (phone number, not just name)
- 7- Must produce valid photo identification.
- 8- Visit schedule will be on a rotation for the time being. Visits will be limited to 1 hour a week this is to provide a fair opportunity for all incarcerated individuals to receive a visit. Below is an example of the visit schedule. The schedule will rotate for example A pod would be Monday the first week, Tuesday the second week, Wednesday the following week and so on. We encourage family and friends to utilize the video visitation option as well.
- 9- Below is an example of the visit schedule for the first week. Times are subject to change. It is very important that you communicate with the individual you are visiting to get a available time slot.
