A local law Establishing a Fund for the Payment of a Percentage of the Cost of

SECTION 1. That pursuant to Section ninety-two-a of the General Municipal Law of the State of New York, a fund has been established for the payment of a percentage of the cost of premiums for hospitalization insurance for these employees who retire from County service after January 1, 1991, and their dependents.

SECTION 2. Pursuant to the aforesaid Section ninety-two-a, paragraph two of the General Municipal Law, the County of Montgomery elects to and hereby provides for, the payment of seventy-five (75%) percent of the cost of the premium for said hospitalization insurance policy for retirees aforesaid of the said County, and further elects to and provides for, the payment of fifty (50%) percent of the cost of the premiums for said hospitalization insurance policy covering the dependents of said retirees, so covered.

SECTION 3. That in order to qualify as a retiree under this local law the individual must meet the age requirements and the minimum service requirements which depend upon the date on which the individual last entered into State or County service.

a.) If the last date of entry was prior to April 1, 1975, Tier 1 and Tier 2 members) the individual must have at least five (5) years service with the State or at least five (5) years combined service with the State and one or more participating employers or agencies.

b.) If the last date of entry was after April 1, 1975 (Tier 3 and Tier 4 members) the individual must have had at least ten (10) years State service or at least ten (10) years combined service with the State and one or more participating employers or participating agencies. If over the age of seventy (70) the individual must have had at least five (5) years combined service.

SECTION 4. The provisions relating to the hospitalization insurance contained in the Civil Service Employees Association Agreement, the Deputy Sheriff's Association Agreement and the full-time non-bargaining Employee Unit Policy shall govern this issue as it applies to these active full time employees.

SECTION 5. That a proper sum shall be provided in the annual budget for the County of Montgomery and appropriated for the payment of the percentage of the total cost of said premiums as specified herein.

SECTION 6. If any clause, sentence or paragraph of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgement, decree or order shall not affect, impair or invalidate the remainder of the local law which shall as to such remainder remain in effect.

SECTION 7. This local law shall take effect upon its adoption and the filing of one certified copy thereof with the County Clerk and three certified copies in the Office of the Secretary of State.
