Legislators Kelly, Sweet, Dimond, Purtell voted nay and Legislator District 8 is vacant. The resolution moves to the full legislature with a negative recommendation.

Item #5: **RESOLUTION ADOPTING INTRODUCTORY LOCAL LAW C (LOCAL LAW 3 OF 2022) - A LOCAL LAW EXPANDING RESIDENCY REQUIREMENTS FOR ASSISTANT DISTRICT ATTORNEYS, SOCIAL SERVICES ATTORNEYS, ASSISTANT COUNTY ATTORNEYS AND ASSISTANT PUBLIC DEFENDERS (COUNTY LEGISLATURE)** Legislators Headwell and Purtell made a motion and seconded, respectively to move the resolution to the full Legislature. Legislators Purtell and Kelly voted nay.
