Ideas to ask volunteers to participate in the comprehensive plan committee: Put a sign up at the transfer station and church bulletin board. Gretchen Popp (with the Charleston Christian Church) suggested putting up a table at the fire department event in September (Charleston and Burtonsville FD).

New Business

Subdivision Approval – Debra Sisson, property owner, represented by the Office of Joanne Darcy Crum, LS. Board approved subdivision. Chairman signed copies. Copy was distributed to Town Clerk's office.

Gretchen Popp – Charleston Christian Church is renovating old wing and needs a variance from the Town Planning Board to tear down walls, put in anew foundation that will push the building back 5' from the current foundation. Will not meet minimum set back requirements. Planning Board Chair will send a letter authorizing the variance to Jdcrum@hotmail.com. Joe made a motion to allow variance, all were in favor. Cemetery Association does not have an issue with the variance.
