- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the "whole action".
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.

Impact on land: The project includes minor tree removal and grubbing during construction. The disturbance of land and impervious surface (7.3 acres) runoff has been mitigated with the erosion & sediment control design and stormwater management facility design.

Impact on Flooding: Parts of this project are located in the 100 year and 500 year flood zones but not within the flood way, so the impact to flooding is minimal. The project has also been designed to elevate portions of the facility above the flood elevations for protection.

Impact on Plants and animals: The proposed action will result in a loss of habitat for flora and fauna, but there are no endangered species that have been identified on the site.

Impact on Aesthetic Resources: The surrounding properties are of similar nature being industrial/commercial uses.

Impact on Historic and Archaeological Resources: The 5/27/2021 letter from OPRHP states that "no properties, including archaeological and/or historic resources, listed in or eligible for the New York State and National Registers of Historic Places will be impacted by this project."

Impact on Transportation: The proposed Travel Center will change the present pattern and volume of traffic in the area. More people and traffic will be drawn to this area due to the nature of the Travel Center and restaurant. Proposed mitigation measures by NYSDOT will be implemented as required and will lessen the potential traffic impacts of the project.

Impact on Energy: There will be an increase in power consumption to operate the proposed Travel Center, however it is expected to be a small impact.

Impact on Noise, Odor, and Light: The facility will increase noise in the area temporarily during construction and also have lasting impacts on noise and light due to the nature of the business of a travel center and restaurant. Although there may be an increase in noise and light, the surrounding properties are of similar nature being industrial/commercial uses. The project proposes the following mitigation of these issues: downward facing LED lights and the front of the property is lined with abbreviates to prevent light from spilling onto Riverside Drive as well as providing visual and noise screening.
