MINUTES OF MEETING HELD JANUARY 21, 2021

A meeting of the Town of Glen Planning Board was held at 7 Erie Street, Fultonville, New York, on Thursday, January 21, 2021 at 6:30 pm.

A quorum of the Planning Board being present, the meeting was called to order at 6:30pm by Chairman, Tim Reilly, followed by the Pledge of Allegiance and a moment of silence. Meeting notes were recorded and drafted by Secretary, Sandy Hemstreet.

Tim Reilly started the meeting by welcoming Susan Whiteman to the Planning Board, having been appointed by the Town Board. He noted that Tim McMurry was re-appointed as well. He requested both Susan and Tim be sworn in and sign their respective Oaths of Office. Signed oaths were returned to Tim Reilly and will be sent to Roxanne Douglass for processing.

The 2021 election of officers was delayed from December and conducted in January. A resolution to reappoint officers was made by Cheryl Huxhold and was approved as follows:

The Annual review of the Planning Board By-Laws was conducted. Tim Reilly requested an update to Article 1 and the last page to state, "As amended on January 21, 2021". A motion to adopt the By-laws with the requested updates was made by Cheryl Huxhold, Seconded by Tim McMurry; all in favor: Tim Reilly, Susan Whiteman, Sandy Hemstreet

Sandy Hemstreet motioned to approve the minutes of the Planning Board meeting held on November 19, 2020. Cheryl Huxhold seconded the motion. Tim Reilly, Tim McMurry, Susan Whiteman voted in favor of the approval.

Due to canceling the December 2020 meeting, there were no minutes to review. Sandy Hemstreet noted the Town of Glen website has been updated with all 2020 meeting minutes and denotes that March, April, and May meetings were not held due to the pandemic shutdowns.

Old Business

United Methodist Church

Tom Pullen, representative for the church, requests a special use permit to run a church at the property they are purchasing on Van Epps Rd; 4.3 acres with a house and 267 road front, off street parking. Tom provided a short for EAF and applied for a building permit. Site plan documents were provided. Tom must provide letters to neighbors on all sides within 500ft of property about upcoming public hearing. Tom requested sample letter to be sent out; must be done at least 10 days in advance, certified and returned receipt. Discussion on setting public hearing.

Buddhist Campus:

Brendan and Asa of Lamont Engineers provided an updated site plan map.

Exhibit B shows Phase 2 temples.

They are looking to proceed with Exhibit C now; parking, garage, storm water treatment pond (2nd devices for treatment of water), and stairs up pavilion with ADA ramp.

Exhibit D is the welcome center- perk tests completed, proposed leach field included, will need to develop well

Exhibit E- larger temple, future phase. Will be ½ way down hill, will need water source but will use current storage already in place (30,000 gallon tank @ the moment). Will have to re-evaluate wells in existing buildings. Roadways included pedestrian only.

Does project require SWPPP? Yes

How high are buildings in floodplain? 2ft up off freeboard in those buildings. Question on whether it should be 3ft up?

Does Prime have copies of changes? Yes

Will there be concrete septic? DEC will review and approve this

Tim Reilly noted DEC did request plans be submitted to them for review. Lamont is aware of this. DOT curb cut already addressed

Next steps: Prime reviews documents, set up public hearing @ February meeting for March, updated SEQR to be re-submitted to Prime. If all goes accordingly April approval on plans is possible.
