MINUTES OF MEETING HELD OCTOBER 21, 2021

A meeting of the Town of Glen Planning Board was held at 7 Erie Street, Fultonville, New York, on Thursday, October 21, 2021 at 6:30 pm.

A quorum of the Planning Board being present, the meeting was called to order at 6:37pm by Chairman, Tim Reilly, followed by the Pledge of Allegiance and a moment of silence. Meeting notes were recorded and drafted by Secretary, Sandy Hemstreet.

Susan Whiteman motioned to approve the minutes of the Planning Board special meeting held on September 9, 2021. Cheryl Huxhold seconded the motion. Tim Reilly, Tim McMurray, Sandy Hemstreet, Rosalie Farina, and Nancy Langdon voted in favor of the approval.

Cheryl Huxhold motioned to approve the minutes of the Planning Board meeting held on September 16, 2021. Susan Whiteman seconded the motion. Tim Reilly, Tim McMurray, Sandy Hemstreet, Rosalie Farina and Nancy Langdon voted in favor of the approval.

Old Business

Western Supreme Buddhist Temple

Tim Reilly noted Lamont Engineering is still waiting on paperwork.

Doug Cole, Prime AE, still awaiting some responses from Lamont Engineering to outstanding items.

411 Reynolds Road Wind Energy Project

Doug Cole, Prime AE, reviewed the comment letter with the Planning Board. As of October 6, there were 12 comments needing to be addressed. 8 of the comments were satisfactorily addressed prior to the Planning Board meeting.

Borrego is currently working on an Avian Study. Confirmed zoning in the proposed site area is Rural Residential. There are small wetlands impact (0.24 acres), primarily associated with the gravel access driveway.

There will be updates needed on the EAF associated with these comments. Once completed, Prime will approve and the letter from the Planning Board can be released to the associated agencies.

Camie Jarrell of GHD Consulting Services and Brandon Smith of Borrego provided updates related to the GHD response letter submitted at 2:30pm, October 21, 2021. Noted as follows:

- 1. Lighting- no permanent lighting along site, just emergency lights at stairs and FAA required lights on turbine
- 2. Footer foundation is concrete, 40ft wide by 10ft deep with a gravel crane pad
- 3. Soil samples will be taken to ensure the proper build of the footer (can be a condition of approval)
- 4. 5 poles will bring connect to main power line and then all electric will run underground to the turbine
- 5. Underground wiring will be at 4ft (plow depth); will ribbon at road to mark buried line
- 6. Setback request- asking for a 1.1x setback (ORES approved) rather than the 1.5x setback. Request is to stay in line with wind resources and to avoid tree clearing and further wetland disturbance. Tim Reilly requested a compromise; asking Borrego gets as close to 1.5x setback as possible
- 7. Storm water analysis completed
- 8. Visual impact study to be conducted; 30a, Severine Lane, & Historic District in Glen
- 9. Noise assessment will be conducted
- 10. Travel Route analysis being conducted
- 11. Signage at site will be a condition of approval

- -County Planning Board would need to review
- -Public hearing would need to be conducted

Pat Oare looking to expand the business. Add a 54,000 square foot cold storage warehouse in the back of the property. 28ft eves, open floor plan. 30ft bays, may have tenants in the future. My have offices in the future. Primary use is warehousing and distribution. Negligible increase in truck traffic. Restrictions to what can be housed will be guided by fire code. Diam not authorized to handle hazmat items.

- 3. Priscilla- What happens at the end of the life of the wind turbine? Has an emergency response plan been requested?

4. Misc- Aquifer- needs to be protected. Is there an overlay that shows where the veins are for it to protect those zones from the solar siting?
