411 Reynolds Road Wind Energy Project

David Strong of Borrego Solar

-Letter received from Borrego/David Strong, dated May 16, 2022 withdrawing the application for 411 Reynolds Road Wind Project. Prime AE and Legal Counsel have been requested to submit their final invoices and close out this account. An email will go to David Strong to ask when the Wind Test Tower

will come down. The Town of Florida and Montgomery County have been notified of this project update.

Borrego Solar- 2621 NYS Rt 5s

Greg Gibbons Steve Long

Doug Cole met with Greg Gibbons to go over SWPPP comments and update the documents. Federal wetland changes have been added to the design. The updated comment letter includes a re-statement of the original conditions of approval for the project, permanent disturbance figures and assurance the plan agrees with the SWPPP.

Borrego Solar requests an extension of their application beyond the standard 12 months provided, due to a lack of NYS incentive dollars being available at the moment to move the project forward. Steve Long indicates the new incentive window opens June 1, 2022. The request is for a 12-month extension, which puts this run out at July 2023. This aligns with previous extensions granted by the Planning Board for solar projects.

A motion to approve a 1-year extension on the Borrego Solar application through July 2023 was made by JD Downing. Tim McMurray seconded the motion.
