COVID update, county and state, Mohawk region numbers have leveled off, yellow designation dodged by having hospital capacity, vaccine rollout will start this week for nursing homes and front line healthcare workers

- Need resolution to increase A1620.1 from \$10,000 to \$13,000, from fund balance. Daily town hall sanitization is the driver
