Water / Sewer Report - Dennis advised regarding fire pump replacement quote in amount of \$43,000.00; his possible retirement at the end of this year but remaining sewer/water department employee; Town vehicle to be used by sewer/water department; and two 30hp pumps in Water District 1 status.
