#### **RESOLUTION No 14 of 2017**

WHEREAS Towns may piggyback the cost of major purchases through contracts already agreed upon and purchased by other municipalities, and

WHEREAS the Highway Department is in need of a new 10-Wheel Plow/Dump Truck,

BE IT RESOLVED that the Town Board hereby authorized the Highway Superintendent to purchase a 2019 10-Wheel Western Star 4700SF Truck from Tracey Road Equipment, Inc., 6803 Manlius Center Rd, East Syracuse, NY 13057 in the amount of \$135,126.00 under the Onondaga Contract #7823 and in addition to purchase the plow and dump body from Viking Cives (USA), 14331 Mill St, Harrisville, NY 13648 in the amount of \$91,235.34 under the Onondaga 2013 Contract. The total cost of the new 10-Wheel Plow/Dump Truck to be \$226,361.34.
