### CORRESPONDENCE

A letter was received from NYS Dept of Transportation acknowledging the Town's request to reduce the speed limit on a portion of West Lykers Road and a portion of Carlisle Road. A speed study will be done.

The 4<sup>th</sup> quarter sales tax was received from Montgomery County in the amount of \$120,721.23.

## REPORTS

There was no report from the Assessor and the Planning Board.

The Town Clerk turned over revenues in the amount of \$472.00 to the Supervisor for fees collected in January. Reprinting of the Town Code book was mentioned as well as the cleaning of the building.

The Highway Superintendent reported that the met with the FEMA agent on the super snowstorm from 2017 and that the Town should be receiving a check in the near future amounting to approximately \$10,000.00.
