The Board was asked when the postponed inquiry hearing would be taking place; this has not been rescheduled at this time.

Resident Margrethe Lauber expressed her disappointment with the public comment section of the August 8, 2018 minutes on marriage equality.

Nonresident Heather Murphy spoke about the responsibilities of the clerk's office in regard to marriage equality.

CORRESPONDENCE

REPORTS

On December 27, 2017 the Board agreed to purchase a 2019 Western Star Plow Truck in the amount of \$135,126.00 and to also purchase the tandem chassis and plow package in the amount of \$91,235.34 which totals \$226,361.34 and

RESOLVED Since said truck has now been delivered and the bill has been received to transfer the sum of \$226,266.82 from DA878 Equipment Capital Reserve to DA5130.2 Machinery EQ and to authorize payment.

Ayes 5 – Kamp, Cuomo, Quackenbush, Thayer, VanKersen Nays 0 The Forest Preserve Users snowmobile club's request for the Town's authorization to use the trails on the land owned by Niagara Mohawk Power Corporation was discussed. This permission must be renewed every five years. Councilwoman Quackenbush motioned seconded by Councilman VanKersen to authorized Supervisor Kamp to sign the consent for the Forest Preserve Users to utilize the trail on the Niagara Mohawk property thereby stating that the Town has no objections to this seasonal snowmobile use.

The need for a budget workshop was discussed and Board Members agreed to meet on Monday, October 22, 2018 at 6:00 PM.
