CORRESPONDENCE

There was no correspondence for the meeting.

REPORTS

Reports were available from the Code Enforcement Officer, the Dog Control Officer, the Justice and the Bookkeeper.

There were no reports from the Town Clerk and the Planning Board.

The Attorney reported that he had responded to a FOIL request from Litz & Litz regarding the dog bite incident that occurred on January 28, 2018; he also reported that he has spoken to Attorney John Bailey from Bailey, Johnson & Peck, the firm hired by the Town's insurance company regarding a notice of claim that has been filed against the Town Clerk and the Town.

The Assessor spoke about the senior sliding scale that is on the agenda.

The Supervisor reported for the Highway Superintendent that funds from CHIP's, Extreme Winter Recovery and Pave NY totaling \$121,513.68 should be paid out to the Town on or before December 17th and that the check for the surplus truck sold through Auction International has been received in the amount of \$37,200.00. He also reported that he has received the Town's portion of the 3rd quarter sales tax in the amount of \$126,413.95.
