BOARD MEMBER Quackenbush presented the following Resolution and moved its adoption. RESOLVED that Supervisor Kamp be and he is hereby authorized to execute a new 3-year contract with the Ames Volunteer Fire Department for fire protection in the town for the years 2020-2022, a copy of which is annexed hereto as Schedule "A".

The audit report of the Town records for 2018 was received from Craig Speers with a few recommendations for the Supervisor/Bookkeeper. The Justice asked that the Town Board have Mr. Speers come in earlier in the year to complete the audit on his books for Court Administration.

The Highway Superintendent spoke with the County about taking down the old Town Highway building. Asbestos testing will need to be done before any future action can be done. The County will provide future information on this.

NEW BUSINESS

Casey Carroll from LS Power Grid New York spoke with the Town Board and residents about the upgrade that will be taking place on the power transmission lines from New Scotland to Marcy including approximately 6 miles within the Town. This work is not expected to take place until 2021-2023. They have requested that the Town sign a Road Use and Crossing Agreement to access the work areas. Councilman VanKersen motioned seconded by Councilman Cuomo to authorize Supervisor Kamp to sign the Road Use and Crossing Agreement with LS Power Grid New York and to attach a copy of said agreement to the Town minutes.
