The need to close the 2020 budget year and to balance all accounts was brought to the Board and the following resolution adopted.

RESOLUTION No 19 of 2020

BOARD MEMBER Quackenbush presented the following Resolution and moved its adoption.

RESOLVED that the fiscal year 2020 be and is closed with the payment of Abstract 13 of the General Fund and Abstract 13 of the Highway Fund and that all accounts be balanced accordingly.

The Highway Superintendent provided pricing for the 2022 Western Star 4700 plow truck with the Henderson Equipment package in the amount of \$244,438.00. The state bid price for this is

Governor Coumo signed the order exempting individuals from coming into the office to prove their income for the STAR program due to COVID-19. The following resolution was presented. RESOLUTION #20 of 2020

BOARD MEMBER Quackenbush presents the following Resolution and moved its adoption. WHEREAS, on March 7, 2020, Governor Andrew Cuomo issued Executive Order Number 202, declaring a State disaster emergency for the entire State of New York; and

WHEREAS, both travel-related cases and community contact transmission of COVID-19 have been documented in New York State and are expected to continue;

RESOLVED, by order of Governor Andrew Cuomo in Executive Order Number 202.83 that the Town of Root adopt by resolution the continuing temporary suspension and modification of laws relating to the disaster emergency as related to Real Property Tax Law Subdivisions 7, 7-a and 8 of section 459-c of the Real Property Tax Law, and subdivisions 5, 5-a, 5-b, 5-c and 6 of section 467 of the Real Property Tax Law, to the extent necessary to permit the governing body of an assessing unit to adopt a resolution directing the assessor to grant exemptions pursuant to such section on the 2021 assessment roll to all property owners who received that exemption on the 2020 assessment roll, thereby dispensing with the need for renewal applications from such persons, and further dispensing with the requirement for assessors to mail renewal applications to such persons.
