# **REPORTS**

The Highway Superintendent reported that the surplus 2011 F-250 pickup truck was auctioned off on Auctions International and a closing bid in the amount of \$16,300.00 was received, this will be discussed in new business. The property owner at the end of Donato Road has contacted the Highway Superintendent about turning over the ownership of the end of the road to him; this will need further review with the Attorney.

The Planning Board reported that they are continuing to review the solar farm law and that in August we may need to extend the moratorium on solar farms.

The Supervisor's monthly report was available and he reported that he received the 1<sup>st</sup> quarter sales tax distribution from Montgomery County in the amount of \$133,758.63.

### **NEW BUSINESS**

Notification has been received from Montgomery County that there will be a tipping fee of \$72.50 per ton to dispose of recycling material beginning June 1, 2021. On Time Waste our recycling provider has asked for clarification on how the Town would like to pay for this additional fee. Board Members have asked that 2 bills be sent, the first bill for the normal monthly recycling charge and a second bill for the tipping disposal fee.

The furnaces for the Town Hall need replaced. Quotes were received from three companies.

Councilman Bramer motioned seconded by Councilwoman Quackenbush to accept the estimate from Allen's Family Heating & Cooling in the amount of \$7,740.00 for the replacement of 2 furnaces in the Town Hall.
