Spectrum Contract

Whereas as, An application has been duly made to the Board of the Town of Root County of Montgomery, New York, by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc. ("Charter"), a limited liability company organized and existing in good standing under the laws of State of Delaware doing business at 2604 Seneca Avenue, Niagara Falls, NY 14305, for the approval of renewal agreement for Charters cable television franchise for ten(10) years commencing with the date of approval by the Public Service Commission.

The franchise renewal agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, as amended, and certain court rulings. A public hearing was held in the Town of Root, New York on September 13th 2023 at 6:50 P.M. and notice of the hearing was published in the Recorder on September 9th 2023.

Now, Therefore, the Board of the Town of Root finds

- 1. Spectrum Northeast, LLC has substantially complied with the material terms and conditions of its existing franchise and with applicable law; and
- 2. Spectrum Northeast, LLC has the financial, legal and technical ability to provide these services, facilities and equipment as set forth in its proposal attached; and

3. Spectrum Northeast, LLC can reasonably meet the future cable – related community needs and interest, taking into account the cost of meeting such needs and interest.
